

plants to meet the shortfall in indigenous production and also to blend superior imported coking coal with indigenous coking coal which is relatively poor in quality. In respect of non-coking coal, shortage is sometimes felt in regions which are distant from coal producing areas on account of movement constraints.

(d) and (e) Supply of coal to core sector is monitored by Deptt. Coal, Ministry of Railways and CIL. In the non-core sector supply of coal is made against

recommendations of the respective sponsoring authorities. Even if the demand assessment by sponsoring authorities is unrealistic, (here it is a possibility of some discrepancy between demand and availability depending on the fluctuations in production in individual industries. Such mismatch gives rise to some secondary trading in non-coking coal. Coal companies draw the attention of sponsoring authorities to instances of misuse of sponsorship whenever such cases come to their notice.
