## Software Technology Park at Bhubaneswar

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECH-NOLOGY (PROF. M. G. K. MENON): (a) and (b) It has been decided to set up a Software Tecknology Park at Bhubaneswar. A project proposal for this has been approved by the Department of Electronics. The total cost of the project is Rs. 4 lakhs for a period of 3 years. The draft Memorandum of Association and Rules and Regulations for the proposed autonomous society have been finalised in consultation with the representatives of the Government of Orissa. Actions have been initiated to set up an autonomous society and also for its registration.
