character, the recruitment to the teaching posts in Kendriya Vidyalaya in different pacts of the country is done on all-India basis and the vacancies are notified in the Employment News and in the leading newspapers throughout the country. The recurits are selected irrespective of the areas to which they belong.

In order to fill up the large number of vacancies in the North-East Region, a special recruitment drive, on all-India level, was made in 1984 for exclusive service in the Region. As a result of special efforts, 51 posts of PGTs, 96 posts of TGTs and 110 posts of PRTs were filled up in 1984.
