consider all aspects of national security in a coordinated and compreensive manner which brings to bear an integrated approach to policy making to deal with internal and external threats including non-military threats. This is to ensure greater cohesion in determining policy options and help in formulating suitable responses in a given as also a situation likely to arise in future. It will also enable policy directions to be taken after assessing all relevant factors.

The National Security Council will consist of Prime Minister (Chairman), Defence Minister, External Affairs Minister, Finance Minister and Home Minister. Other Central Ministers and Chief Ministers of States may be invited to participate in the meetings of the Council where necessary and when specifically requested to do so.

- (e) The BE Workers' Union had sought insurance of costly materials carried by train and provision of escort. The Commy is now obtaining insurance for equipment being transported; it has not been found necessary to detail an escort particularly when items are being carried in briefcases or small packages.
