THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND THE MINISTER OF STATE IN THE MINISTRY OF PROGRAMME IMPLEMENTATION (SHRI BHAGEY GOBARDHAN): (a) Yes, Sir.

(b) to (d) No Potable Water Supply Scheme proposed to be executed by Rajasthan Government is pending with Planning Commission for clearance. Two irrigation projects, namely, Sidhmukh and Nohar proposed to be executed by the Rajasthan Government in the Eighth Five Year Plan are pending investment clearance. Irrigation projects are not directly received from the State Governments in the Planning Commission for investment celarance. These are received from the Technical Advisory Committee of the Ministry of Water Resources. Planning Commission has not given investment clearance to any new irrigation project for Annual Plan 1990-91 of Rajasthan The Eighth Five Year Plan of Rajasthan is yet to be finalised. The investment clearance of the above mentioned irrigation projects will depend, among other factors on relative priority to be attached to such projects within the total resources available with the State for Eighth plan.

Achievements of Open Universities
