THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI JANESH-WAR MISHRA): (a) and (b) It was decided not to continue with the services of Shri G. B. Meemamsi, Executive Director, C-DOT since he had cross 60 years of age which is the maximum prescribed as per the by-laws of C-DOT. The tenure of Shri D. R. Mahajan, Director, C-DOT had expired and it was decided not to grant any extension to him.
