## Insurance facility for people on election duty

- (b) whether it is also a fact that a large number of persons engaged in election work suffer grievous injuries and even death while on election duty;
- (c) if so, whether Government propose to provide an insurance cover to those persons;
- (d) if the answer to part (c) above be in the negative what are the reasons therefor?

THE MINISTER OF STEEL AND MINES WITH ADDITIONAL CHARGE OF THE MINISTRY OF LAW AND JUSTICE (SHRI DINESH GOSWAMI): (a) and (b) Though cases of booth capturing and violence have taken place during the recent elections, it cannot be treated as a common feature.

(c) and (d) Such a proposal has not been considered necessary.

The foreign exchange earned does not include the foreign exchange received by the Travel Agents and paid to ITDC in Indian currency.

- (b) The increase in foreign exchange spending is mainly due to import of goods for sale at Duty Free Shops at International Airports against foreign currency.
- (c) and (d) No, Sir. The foreign tours have been / are undertaken by ITDC Executives in connection with foreign projects / ventures, holding food Festivals of India, participation in annual conventions of World bodies (like World Tourism Organisation, Pacific Asia Travel Association, American Society of Travel Agents) etc. Though Quantification of benefits from each individual foreign tour, in terms of business generation, is not feasible, these have positively helped ITDC in achieving increased profitability.
