THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI AJAY SINGH): (a) Yes, Sir.

(b) (i) Induction of 3-phase traction motors in the present diesel and electric locomotives is not feasible on technoeconomic considerations.

(ii) A new design of electric loco motive with 3-phase traction motors is proposed to be imported along with technology transfer, for future manufacture in the country.

(iii) On diesel locomotives, 3-phase technology is proposed to be introduced first on 2200 horse power Metre Gauge locomotives, for which a tender has been floated. This technology has not yet been wejl established on very high horse powerful diesel locomotives.
