Over-crowd at New Delhi Railway Station

- (c) The shops are located on Railway land under licence to the Municipal Corporation of Delhi.
 - (d) Yes, Sir.
- (e) The Municipal Corporation of Delhi and the Delhi Administration have been requested to hand over vacant possession of the land to the Railways, for taking up improvement to the circulating area in front of New Dehi Railway Station. A Committee of representatives of the Railways, Municipal Corporation of Delhi and Delhi Development Authority has been set up to prepare a scheme for development of this area.

cases of procedural delays in the clearance of the research projects by the Research Council of the Institute have been cited. The cases relate to the Agro-Energy Centre, wherein out of five research projects, only one was approved by the Research Council.
