(a) what is the present per capita consumption of foodgrains in India; and

(b) how does it compare with the position in advanced Countries?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI NITISH KUMAR) : (a) The level of consumption at any point of time depends upon population; production and availability; changes in stocks held by producers, traders and consumers; income distribution; pattern of consumption etc. The provisional estimates of per capita net availability of foodgrains for consumption for 1988 and 1989 are

446.5 grams and 496.6 grams respectively per day.

(b) It may not be appropriate to compare the foodgrains consumption in India with those of advanced countries, as the food habits differ from country to country, food baskets also very among countries.
