Weeding out of All India Services Officers of doubtful integrity

\*381. SHRI V. GOPALSAMY: SHRI TINDIVANAM **VENKATRAMAN:** 

Will the PRIME MINISTER be pleased to state:

- (a) whether Government had initiated action against officials of the Indian Administrative Service, Indian Police Service and other allied services during the last three years;
- (b) if so, the details thereof category-wise and year-wise;
- (c) whether Government propose to weed out officials of doubtful integrity from these services in the near future; and
- (d) what steps are being proposed administrative to revamo the machinery throughout the country to weed out corruption, inefficiency and also non-performance at the administrative level?

THE PRIME MINISTER AND THE MINISTER OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRI VISHWANATH PRATAP SINGH): (a) to (d) The respective cadre controlling authority for each service is competent to take action against officials

service. The State Government is also competent to take action against officers of the All India services when they are working in connection with affairs of the State. The information relating to the number of officers in different cadres against whom action has been taken is not maintained centrally.

Apart from taking disciplinary action under relevant rules the provisions of FR 55(i) read with rule 16(3) of AIS(DCRB) Rules, 1953 and Rule 48 of Central Civil Services Pension, Rules, 1972, are also invoked by Government to weed out Government servants, who have out-lived their utility and have becocome ineffective as also those whose integrity is doubtful. This is a continuous process. The objective of these special provisions is to improve the efficiency and strengthen the administrative machinery at all levels of the Government and to provide a clean administration.

## Dangers of Global climatic changes

- \*385. SHRI B. K. HARIPRA-SAD: Will the Minister of EN-VIRONMENT AND FORESTS be pleased to state:
- (a) whether Government's attention has been drawn to an article which appeared in the Network of April 1990 on the dangers of Global climate changes;
- (b) if so, what is Government's reaction in the matter;
- (c) whether it is a fact that recent Cyclone in the Eastern Coast is a part of the danger of climatic changes; and
- (d) what policy/programme changes are proposed in this area in reducing Ozone hole and greenhouse effect?

THE MINISTER OF STATE IN THE MINISTRY OF EN-

VIRONMENT AND FORESTS SMT. MANEKA GANDHI): (a) Yes, Sir.

- (b) The extent of global changes which may occur has not been established scientifically.
- (c) No, Sir. Occurance of cyclonic storms in the Indian seas in pre-monsoon and post-monsoon seasons is a usual feature and is not a result of any climatic change.
- (d) India's contribution to any possible global change is negligible. However, India is studying all aspects of global change carefully and participating in international discussions periodically held with the objectives of protection of ozone layer and management of climate change.
