(b) and (c) The senior most officer was short of requisite ex-Sangathan perience in the nearly 5 years, at the time of consideration of his candidature for promotion to the post of Assistant Commissioner (Admn.) in October, 1988. In the circumstances, the post was circulated to be filled up by transfer on deputation. Since he fulfilled the requisite qualificathe selection Committee tion. recommended him for appointment to Assistant Commissioner (Admn.) subject to eligibility being confirmed by Department of Personnel and Administrative Reforms. D. P. AR. opined that they had no objection provided the requisite requirement of experience was relaxed by the competent authority. The competent authority decided that the Recruitment Rules for the post may be amended first and then the recruitment finalised. Meanwhile the officer moved the High Court at Delhi and on the directions of the Court, he was promoted as Assistant Commissioner (Admn.) an ad-hoc basis w. e. f. 6-4-1990.
