

Vacancies of Teachers earmarked for Promotion and Recruitment in Kendriya Vidyalayas

2238. SHRI GURUDAS DAS GUPTA: Will the PRIME MINISTER be pleased to state:

(a) what are the details of the vacancies earmarked for appointment through promotion and Direct recruitment in respect of different categories of teachers of the Kendriya Vidyalayas for the sessions 1988-89, 1989-90 and 1990-91;

(b) whether there is any backlog in general or reserved categories;

(c) if so, the details there of and the reasons there for; and

(d) what efforts have been/are being made in this regard ?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI CHIMANBHAI MEHTA): (a) Details are given in Statement I (See below)

(b) and (c) Rules do not provide for clearance of backlog in respect of general categories. The details

of backlog vacancies in respect of SC/ST and Physically handicapped are given in statement II (See below)

(d) A special combined advertisement for the reserved category posts of Primary Teachers/ Trained Graduate Teachers and Miscellaneous Categories of teachers was made in February, 1989 in the News Papers throughout the Country by the Kendriya Vidyalaya Sangathan (Head-quarters) for filling up the vacancies.

The candidates found suitable by Regional Selection Committees have been empanelled and offers issued by Regional Offices, except in the case of Miscellaneous Category of teachers of seven regions where recruitment is in hand in the respective regional offices.

The posts of Post Graduate Teachers for reserved categories have been re-advertised in December, 1989, as all the vacancies could not be filled up in the first attempt.

The Regional Offices have been asked to report the position of vacancies for Primary Teachers and Trained Graduate Teachers to enable the Kendriya Vidyalaya Sangathan to readvertise these reserved vacancies also.
