KHAN): (a) and (b) Due to the all round increase in the cost of inputs, the present cost of generation & purchase of electricity by DESIJ is substantially more than the average realisation. It is, therefore, necessary that the DESu may, with the approval of Delhi Electric Supply Committee and Municipal Corporation of Delhi, consider rationalisation of the power tariff in Delhi, so as to ensure financial viability of DESU and consequent proper supply of electricity in the National Capital, So far no decision to rationalise the electricity rates has been taken by the afore metotioned authorities.

This ratio com pares very unfavourably with the ratio ob taining in developed countries like U. K., USSR and Japan;

Efforts are being made to augment the availability of doctors by opening medical institutions and also to improve patient care by establishment of more hospitals in the Government and private sector.

(b) to (d) Government is continuously monitoring the power supply position in the State and is taking steps to bridge the gap between demand and availability subject to overall availability of power in the grid. Some of the measures taken by the Go vernment tq increase the availability of power in the State include expeditious commissioning of new capacities, optimum utilisation of existing capacities reduction of T&D lossess, assistance from neighbour ing States/Systems to the extent possible, maximi'sina generation from existing capa cities and intensive monitoring of the grid operations an coordination of power supply.

Glaxo having a capacity of 568 Kgs. and M|s. Wyeth Labs, with a capacity of 50 Kgs. The stage of manufacture permitted is basic. Of these only M|s. Glaxo is reporting production,
