## SHRI G. SWAMY NAIK:

will the Minister of PETROLEUM AND CHEMICALS be pleased to refer to the answers to Unstarred Questions 1459 and 1460 given in the Rajya Sabha on the 26th March, 1990 and state:

(a) whether it is a fact that the position of bulk vitamins Bl, B2 E, B6, and B12, areidentical as vitamin A and vitamin C;

(b) if so, on what consideration vitamin A and C have been brought under price control and other bulk vitamins have been excluded;

(c) whether it is a fact that finished medicines Pased on all bulk vitamins  $ar_e$  under price control though certain bulk vitamins are outside price contiol' and

(d) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI BHAJMAN BEHERA): (a) and (b) Vitamin 'A' and 'C' are of mass consumption. Further Vitamin 'A' is required for eye ailments and is vitally important for prevention of blindness.

(c) and (d) All single ingredient vita-min formulations containing individual Vitamins specified in the Secord Schedule of the DPCO, 1987, sold either in brand name or in generic name are exempted from price control, except the single ingredient Vitamin formulations based on the bulk drugs Vitamin A and Vitamin C sold in brand name.
