- (i) Duration of the course from one year to two years after 10 plus 2 Course.
 - (ii) Course contents to be revised and a number of subjects to be added in order to improve the knowledge and skills of the pharmaciests.
 - (iii) Minimum standard of passing the examination of Diploma to be raised from 40 per cent to 50 per cent.

The proposal is under consideration of the Central Government.

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND **CHEMICALS** (SHRI **BHAJ-MAN** BEHERA): (a) and (b) The recommendations contained in the Hathi Committee Report were taken into consideration while formulating the first Drug Policy in 1978. This policy was reviewed and a set of Measures were announced in December 1986. The current Drug Policy is under review. The experience gained so far in its implementation and the recommendations of Hathi Committee would also be taken into consideration for this purpose.
