T.V. advertisement on Pan Parag

2336. SHRI B. K. HARI-PRASAD: Will the Minister of of INFORMATION AND BROAD-CASTING be pleased to state:

- (a) whether Government have seen news reports pointing out the havoc caused by various T.V. advertisements in promoting several undesirable and un-healthy products such as Pan Parag causing cancer; and
- (b) whether any communication/reports have also been received from voluntary agencies and other medical R and D. Institutions such as ICMR/WHO on the subject and if so, the details thereof and corrective steps taken/proposed?

THE MINISTER OF INFOR-MATION AND BROADCASTING AND PARLIAMENTARY AF-FAIRS (SHRI P. UPENDRA) : (a) and (b) The Government have seen occusional reports questioning the desirability of telecasting advertisements meant to promote certain products. In the present specific case Ministry of Health have opined that there is no clinching evidence at present to conclude that consumption of Pan Masala causes cancer. It is Poordarshan's policy not to advertisements promoting undesirable and unhealthy products.
