

**Construction of Bridges under
Shahpur Rehabilitation Project**

Will the Minister of HOME
AFFAIRS be pleased to state:

(a) whether Government are aware that the refugees rehabilitated under the Shahpur Rehabilitation Project, District Betul, Madhya Pradesh are not able to take their agricultural produce to the nearby industrial town of 'PATTHAKHURD' and 'SARANI' as there is no bridge on the rivers 'TAWA' and 'BHARANGI'; and

(b) if so, whether in order to make these refugees self-sufficient, Government would sanction the construction of these bridges so that the refugees can sell their farm produce in the above towns and get remunerative prices thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SUBODH KANT SAHAY): (a) and (b) One bridge over river Tawa connecting the Shahpur Rehabilitation Project with the Shahpur Sub-Divisional town already exists. Besides, Rs. 19.50 lakhs have already been sanctioned for construction of a submersible bridge each on Bharanga river and Latia Nallah. As regards the construction of another bridge over river Tawa, it may be mentioned that the proposed site of the bridge is outside the project area. Moreover, the two industrial towns are in-accessable from the Shahpur Project only during the rainy season. During the remaining part of the year, the migrants do not experience any difficulty in crossing the Tawa river to reach these two towns. It may also be added that the Shahpur Rehabilitation Project stands transferred to the State Government with effect from 16-1989.

Bringing Neraji's ashes to India

(c) whether Government are planning to entomb the pre-relicious remains in a specially built national monument: if so, when and by what time?

(b) and (c) In recent years some individuals and groups have urged that the said ashes be brought back from Japan. However, other individuals and groups have objected to such a proposal.
