- (vi) On 30-4-90, a powerful bomb exploded in a bus plying between Uttam Nagar and ISBT in which two persons were killed and 32 were injured. A case u/s 302, 307, 120-A IPC, 3/4/5 Expl. Subs. Act and 3/4/5 TADA has been registered at Police Station Mangolpuri.
- (B) During the investigation of these cases, the group behind the explosions has been identified. While the Crime Branch has already arrested one of them, Sub-Inspector Beant Singh, the others including Constable Guriasbir Singh from Delhi Police) and terrorist. ä Mangal Singh from Punjab are absconding.
