made a governor... (interruptions)... Then, Mrs. Chandravati is the Lt— Governor of Pondicherry and she is an active political Reader of the Janata Dal in Haryana. And, Madam, so many politicians have been appointed by this Government. Mr, Wadhwa submitted a report to the Government. Both the Houses of Parliament are sitting today. But, so far, that report has not been placed either here or in the Lok Sabha. This Government is telling about the dignity of institutions and individuals and yet what they are doing is contrary to what they say. They have no respect for the Commissions of Inquiry and now they are going to stop the provisions which were introduced by the previous Government. I would only say that they have no intention to respect either individuals or institutions. They are telling that previous Government was only politicising every issue. But I would say that the present Government is politicising each and every issue and they are only pointing their accusing fingers at the Congress (I) and they have not changed their attitude.

Since there is no bonafide intention on the part of this Government, I am moving this amendment of mine, Thank you, Madan*-

THE VICE-CHAIRMAN (SHRI MATI JAYANTHI NATARAJAN): The question is:

"That at page 1, after line 4, the following new clause be *inserted*, namely:

'1A. STATEMENT BY MINISTER

Bomb blast in Batala on 3rd April 1990

THE MINISTER OF HOME AFFAIRS (SHRI MUFTI MOHAMMAD SAYEED);. Madam, I rise to inform the House of the sad and disturbing incident of bomb explosion in Batala.

There was powerful bomb blast on April 3 at about 2, 45 pm when Ramnavami procession of about 3500/4000 persons was passing near Subzi Mandi in Batala City of Gurdaspur District.

According to reports available 31 persons have been killed and 70 have been injured. The injured were immediately rushed to the hospital. Those seriously injured were shifted to the SGTB hospital at Amritsar.

The District Administration bad taken precautions to provide security arrangements with the procession Two BSF companies under the command of a Deputy Commandant had been deployed. One Inspector, 5 NGOs, 20 Head Constables and 100 Constables of the District Police under the command of S. P. (Operations) along with the Dy- S. P. Batala and SHOs of Police Station (City) and Police Station (Sadar) Batala were on duty along the route and with the procession.

There were some disturbances after the incident but these were soon brought under control. Curfew was imposed as a precautionary measure.

Immediately after the incident. SSP Batala visited the spot. Senior officers including DC Gurdaspur, Com Division, missioner Jalandhar DIG Police (Border) along with the Police (Border), IG BSF and DIG BSF rushed to the spot. Ten addition al companies of para military forces were sent tfo Batala. Batala City was divided into 8 Sectors, and Magistrates and Police Officers were put on duty in each Sector. A peace Cornmittee meeting was held in evening of 4-4-1990.

The Governor accompanied by Advisor Incharge of Home Affairs, Chief Secretary and DGP visited the injured in Amritsar and also visited Batala. I visited Batala on 6-4-1990 along with a delegation comprising representatives of different political parties. We first went to Amritsar and met the victims of the bomb blast in SGTB Hospital. Later we went to Batala where I and the other members of the delegation heard the leaders of various political parties and organisations. We also visited the injured persons undergoing treatment in civil hospital Batala. I held a review meeting on law and order arrangements with civil and police officers.

All efforts are being made to trace and apprehend the culprits. The State administration has been instructed to continue deal firmly with terrorist an antinational elements.

The manner in which a religious procession has been attacked shows clearly that the intention of the perpetrators of this crime was to provoke a communal backlash. We are certain that like ail previous attempts by the terrorists to drive a wedge between the two major communities of Punjab, this* attempt too will fail.

I am sure the Members will join the in condemning this dastardly act in the strongest possible terms and in convoying our heartfelt sympathies to thi; bereaved families. No effort will be spared to round up the culprits (ltd bring them to book. The

Government is ensuring provision of medical and other relief to those injured and for *exgratia* assistance to the families of the deceased.

I appsal to the Members of this House and through them to the entire ntaion to strengthen the hands of the Government in dealing with the attempts of the terrorists to disrupt the centuries' old ties between the Hindus and Sikhs in Punjab.

SHRI V. NARAYANASAMY (Pondicherry): Madam Vice-Chairman, This is a dastardly crome in which 36 people have been killed in Batala. When the Ramnavami procession was going on, a severe bomb blast took place and the people went on a rampage. According to information available, the people died due to firing by the Police. The very important aspect is that there are two versions of the bomb blast. One version is that the bomb was kept on a bicycle and the blast took place. Therefore, the people died in the area where the procession was going on. The procession started at 1-45 and the incident took place at 2. 45 in a crowded area of Subzimandi. Another version is that in a Maruti Gypsy vehicle the bomb was planted and the police mark was there. The blast took place from the vehicle. Therefore, I would like to know from the hon. Home Minister whether the blast took place from the bicycle or from the jeep.

There i_s a clear statement by the BJP Working Committee member, Mr. Baldev Mittal, who showed about 12 empty cartridges of bullets. He said that the Police fired among the crowd and, therefore, most of the people died. I would like to know whether it is a fact.

Thirdly, I would like to know whether there was any intelligence report with the Government saying that there will be disturbance when the Ramnavami procession passes, What preventive steps had the Government taken to give security to

the people who were moving with the procession? i would like to know whether this Government actually took care of the people. It is a terrorist area where the procession was going on. They were fully aware of the fact that there will be disturbance. What preventive steps did the Government take? Madam, I Would like to give small details about the situation. (Time-bell rings) I will conclude in a minute. Madam, wall posters had been pasted in that area saying that many terro rists had died due to police attack and their death rituals are being per formed in many areas. There was a call given by the terrorists organi sations that the people who are living in that area should support their cause. Moreover, newspaper adver tisements are coming in support of the terrorists. Newspaper organisations have been threatened to carry on these advertisements. Terrorists are threatening the people in thin area through the loudspeakers.

I would like to have clarifications from the hon. Home Minister on these four points. What action 'has this Government taken? The Minister said that it has been divided into 8 zones and Peace Committees have been formed. I would like to know whether the political parties have been given representation in the Peace Committees or not.

DR. NARREDDY THULASI REDDY (Andhra Pradesh): Madam, the first clarification that I want to seek, is whether there was any provocation to this abhorrent, acrimonious inci dent. Secondly, I want to know whether there is any clear-cut, speci fic programme with the Government to tackle this terrorist activity. Third ly, i_s it a fact that previously five bomb blasts have taken place in Bata la? If it is so, what action has been taken in those cases? ' Fourthly, is there anyt link between the terrorist activities of Puniab and Kashmir? My fifth point is that the terrorists are using AK-47s. They are using bombs;

they are using rockets, and tomorrow they may use missiles also. So,] want to know whether the Govern-ment is ready to face the situation, Madam, my last point is that the Governor of Punjab has not been allowed to enter the Civil Hospital. Who are those persons who obstructed the entry of the Governor into the Civil Hospital? So, these are the points on which I seek clarifications.

SHRI ASHIS (West Bengal): Madam Vice-Chairman, this statement was made perhaps on the 3rd April in the Lok Sabha. Today is 10th. Some development must have taken place in between, and that too must have been incorporated in this. But, Madam, I will be on a limited point. So many people have been killed in the bomb explosions, and the bombs were thrown at a Ram Navami procession in a crowded area. It is reported that the Police opened fire after the rampage. Thereafter the agitated mob drove to set fire to a Gmrtadwara. In the process, five people sustained sword injuries. Two constables and other sustained swOrd injuries. It is also reported that the postmortem shows that at least two or three of them were victims of bullets, not ag the hon. Member, Mr. Narayanasamy, said that most of them were victims of police bullets. Whether thjey are police bullets or other bullets, that has to be ascertained. My point is that this is the first religious procession that has been attacked in that area. Naturally, and it is obvious that the perpetrators of this had one particular objective to see that communal tension devlelops there and the communal strife begins. Since the National Front Government has taken over perhaps. this is the second major incident after Abohar massacre. (Time bell rings) It sefems that the Babbar Khalsa owned responsibility for this. I want to know whether it is a fact, and what attempts have been made to chase and find out those Babbar Khalsa elements. The Minister said

THE VICE-CHAIRMAN (SHRI MATI JAYANTHI NATARAJAN) Now, I am not going to call any othei Member, (Interruption) I tell yoi why. (Interruption) Please hear me.

SHRI SANTOSH BAGRODIA (Rajasthan): I was the first to give my name.

THE VICE-CHAIRMAN (SHRI MATI JAYANTHI NATARAJAN): The House has heard what happened during the previous clarifications All of you have spoken. I allowed everybody to speak.

THE VICE-CHAIRMAN (SHRIMATI JAYANTHI NATARAJAN): Kindly do not interrupt me when I am speaking Let me finish what I have to say.

SHR1 S S. AHLUWALIA: No, nti. Thi $_{\rm s}$ is not the way.

THE VICE-CHAIRMAN (SHRI-MATI JAYANTHI NATARAJAN): Let me finish what I am saying. (Interruptions)

SHRI S. S. AHLUWALIA: We are here by our right. (*Interruptions*) Yesterday morning i have given my name for seeking clarifications.

THE VICE-CHAIRMAN (SHRIMATI JAYANTHI NATARAJAN): You have already sought clarications on the previous statement.

SHRI M. M. JACOB (Kerala): Previous subject was different.

THE VICE-CHAIRMAN (SHRIMATI JAYANTHI NATARAJAN): I knew the Members would raise the same issue. Therefore I called you as th_e first name on the list. I am not calling an_{ν} other speaker now because we have a further statement on Nepal.

SHRI M. W. JACOB: Nepal is different.

THE VICE-CHAIRMAN (SHRIMATI JAYANTHI NATARAJAN): If I call one name, then all the Other Members get upset. It is impossible to conduct the House like this.

SHRI S. S. AHLUWALIA: It seems that there is a crisis of presiding' officers in the House. There is nobody to rescue you and relieve you. If i am not given a chance then I will boycott the House.

SHRI MUFTI MOHAMMAD SAYEED: Madam, Information was received that there were two bomb blasts, one at police station Tilak Nagar and the other at police station Rajouri Garden, around 1-30 p. m. today. Nine police personnel were injured in the two blasts. Two of them have been admitted in the hospital while the remaining have been discharged after first aid.

It is suspected that some terrorist group from Punjab is behind these bomb blasts and that a timing device might have been used. Cases have been registered at the police stations and given to the Crime Branch for investigation. A general alert has been lounded throughout Delhi.

Special vigilance is being maintainec in public places like railway stations airports, cinema halls, bus terminals and busy market areas. Access cont rol is being introduced in all polia stations. Every possible precautio nary measure is being taken to ensure that such incidents do not recur in the future.
