Rs. 10 crores has not yet been reimbursed as a result of which the financial institutions are not releasing Bridge Loan to entrepreneurs against capital subsidy:

- (b) if so, by when Government will release these arrears so as to save the industries from crisis; and
- (c) whether this amount will be paid along with interest?

THE MINISTER OF INDUSTRY (SHRI AJIT SINGH); (a) to (c) The Central Investment Subsidy is first disbursed to the eligible units by the State Governments Union Cerritories. The Central Government only reimburses the subsidy amount after the State Governments/Union Territories perfer their claims. As on 23-3-1990. claims amounting to Rs. 6.02 crores received from the Government of Goa reimbursement. These are pending will be reimbursed as and when funds become available and subject to their being found eligible for payment. There is no provision for payment of interest on reimbursements made under the Scheme.
