REPORTED ATROCITIES AGAINST SCHEDULED CASTES WOMEN IN MADHYA PRADESH

SHRIMATI JAYANTHI NATARA-JAN (Tamil Nadu): Madam Deputy Chairman, I want to bring a very important issue to the notice of the House. Two of our Members, Kumari Sayeeda Khatun and Shrimati Satya Bahin have also gone to the place. Madam, in Madhya Pradesh on Holiday, centuries old obscene practice of asking Scheduled Caste women to dance naked with their men beating the drums was again brought into being near a village near Shivpuri. The men were asked to beat the drums and the women were told to come out and dance naked in pursuance of an age old custom and when the women refused, they were severely beaten up by the local people who belong to a particular political party, a fundamentalist political party. They were severely beaten and one man was also killed. Madam, though an inquiry was ordered by the State Government, three most important people, the Sarpanch of the village and two others who were responsible for bringing this about have not been arrested but other people have been arrested who have got nothing to do with the incident.

Madam, we are very worried because the people involved in the incident have not been arrested because of their connections with a particular political party. Madam therefore, we have seen that justice will not be done and this is the kind of practice which is going to result in taking women back to the dark ages. Therefore, my request to you is that we might immediately have a discussion in the House on the rising atrocities against women regardless of partylines. Secondly, Madam the Home Minister may be directed to enquire into the matter because the State Government is not doing anything about that and we are very much worried that this kind of practice will spread. Two of our have gone to the place and they have seen what has happened.
