(d) the steps taken/being taken to curb terrorism and stop killings of innocent people in Punjab alongwith the results thereof?

THE MINISTER OF HOME AF-FAIRS (SHRI MUFTI MOHAMMAD SAYEED): (a) and (b) According to information available, 126 persons including 23 police personnel were killed by terrorists in Punjab during January 1990. In February 1990, 95 persons including 21 police personnel were reported to have been killed. 57, and 44 terrorists, respectively, were killed in January and February, 1990 and 53 and 77 terrorists respectively were arrested during two months by the security forces. Information regarding number of security personnel and terrorists injured during the period is being collected.

- (c) Information in this regard is being collected and will be laid on the Table of the House.
- (d) The State Government are taking stern security measures by way of intensified patrolling in the sensi tive areas; nakas at volunerable points, launching of special operations and establishing special police pickets in the terrorist infested areas etc. for curbing such violent incidents in the state.
