"New post offices, telegraph office and telephone exchanges to he set up in Orissa

- *28. SHRI SUBAS MOHANTY; Wil the Minister of COMMUNICATIONS be pleased to state:
- (a) what are the targets set by Government to open new Post Offices, Telegtaph Offices and new Tele-phone Exchanges in Orissa during the year 19S0-91;
- (b) whether the targets for the 1989-90 have been fully achieved; and
- (c) if so, what are the details thereof?

THE MINISTER OF STEEL AND MINE\S WITH ADDITIONAL CHARGE OF THE MINISTRY OF LAW (SHRI JUSTICE DINESH AND GOSWAMI): (a) Post Offices: The norms to be followed during the Eighth Plan for opening of new Post Offices are at present being reviewed. Statewise targets for 1990-91 are likely to be fixed only after the exercise is completed.

Telegraph Offices:

200 Telegraph Offices working on phonocom are proposed to be opened in 1990-91.

Telephone Exchanges:

About 83 new exchanges are proposed to be opened in Orissa in 1990-91 This is subject to availability of equipment.

(b) and (c) Post Offices:

The targets fixed for opening of Post Offices in Orissa under Annual Plan 1989-90 has not been fully achieved. Since 1-4-1989, 18 branch offices have been opened in the State. Proposals for 81 more branch post offices and departmental Sub Post i Offices have been taken up.

Telegraph Offices:

97 Combined Offices on phonocom have already been opened and 20 more working on phonocom basis are likely to be opened by March, 1990.

Telephone Exchanges-.

The targets for 1989-90 have been fully achieved. As against the targeted 21 exchanges a total of 29 exchanges have been commissioned so far during 1989-90 in Orissa

Terrorist activities in Punjab, Jammu and Kashmir

*29. SHRIMATI RATAN KUMARI: SHRI S.K.T. RAMACHAND-RAN:

Will the Minister of HOME j AFFAIRS be pleased to state:

- (a) whether there have been an alarming spurt in terrorist activities in Punjab and Jammu and Kashmir recently;
 - (b) if so, the reasons therefor;
- (c) the number of persons killed in those States during the last three months, monthwise;
- (d) the steps taken by Government to meet the situation; and
- (e) the steps Government propose to take to solve Punjab and Jammu and Kashmir problems?

THE MINISTER OF HOME AFFAIRS (SHRI MUFTI MOHAMMAD SAYEED): (a) and (b) Terrorist violence has contained in Punjab largely due to attempts of militant factions to gain supremacy over one another by creating a fear psychosis among the people. In Jammu & Kashmir the recent escalation in violence by the secessionists is largely as a reaction to the firm handling by the State

Administration to assert its authority and curb the activities of the secessionists. The Terrorists in both states have also been getting inspiration and guidance from across the border.

(c) According to information available the number of persons who have lost their lives during the relevant period is as follows:—

- (d) The situation in the two states is constantly under review. The State Govts, concerned have taken adequate security and other measures to deal with the situation. Central assistance by way of deployment of paramilitary forces, etc. has also been ex tended as and when required.
- (e) The problem in the two States has become complicated 'over the years. The Government are of the view that it requires a national and all Party approach for a solution. Discussions have been held with leaders of various Political Parties with this end in view.
