(b) and (c) Universities which are established after 17th June, 1972 have to be declared fit by the University Grants Commission for financial assistance from Central sources. Such a declaration is made by the Commission if it is satisfied that the conditions

stipulated in the rules framed under Section 12-B of the UGC Act have been fulfilled. Since Medical/Health Universities are a recent development, the Commissio": has constituted a Committee to frame rules for declaring Medics 1/Health Universities fit to receive assistance from Central sources under Section 12-B of the UGC Act.
