#### Censor of video news

174. SHRI SANTOSH BAGRO-DIA: Will the Minister of INFOR-MATION AND BROADCASTING be pleased to state:

- (a) whether it is a fact that video news magazines are hoing consored; and
- (b) if so, what effect it is likely to have on the general policy of Government regarding free press?

INFORMA-THE MINISTER OF TION AND BROADCASTING AND PARLIAMENTARY AFFAIRS (SHRI P. UPENDRA): (a) and (b) Yes, public Sir. All firms intended for exhibition in India are required to be certified by the Central Board Film Certification. "Film" includes a vide film. Therefore, video films, including newsreels meant for public exhibition, have to be presented to the Board for certification. The medium of cinema, both celluloid video, is different from the print medium in their impact and reach. There is, therefore, pre-censorship for film medium. In view of this, it has no relation with the general policy of Government regarding free press.

## Participation of Indian political leaders in a political conference in Kathmandu

175. SHRI SANTOSH BAGRODIA: Will the Mintster of EXTERNAL AFFAIRS be pleased to state:

- (a) what is the reaction of the Nepalese Government about the participation of Indian political leaders in a political conference in Kathmandu; and
- (b) whether Government of India approve this kind of activity by political leaders in foreign countries?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI I. K. GUJRAL): (a) Government are not aware of any official reaction or demarche by the Government of Nepal on this subject.

(b) The Panticipation by Indian political leaders in the political conference in Kathmandu was outside the purview of Government of India. So the question of Government approving or otherwise does not arise.

UN-NIKRISHNAN): (a) In February. 1989, the Cochin-Madurai Road which covers a distance about 116 Kms. in Tamil Nadu has been declared as a ional Highway, No decision to convert any other State Highway into a National Highway at present has been taken.

- (b) There is no propsal to develop Trivandrum-Ambasamudram 'road as a National Highway
  - (c) Does not arise.

# Purchase of pistols from Szech Company

Since samples from the consignments ceived were tested and not found according to the specifications, the contract with the Firm was terminated. The firm backloaded the consignments at their cost.

### National Highway between Dindigul and Kottayam
