In the case of IRS system, the acquisition/processing and dissemination of the satellite data to the user community will also be a major responsibility to be discharged by the Department of Space. During the Eighth Five Year Plan period, it is envisaged to complete the operationalisation of IRS-IR Spacecraft, IRS-IC Spacecraft, INSAT-II Test Spacecraft, Augmented Satellite Launch Vehicle (ASLV), and Polar Satellite Launch Vehicle (PSLV). Also development of Geosynchronous Launch vehicle (GSLV) and Cryogenics engine and Stage constitutes an important activity proposed to be carried out during this period.

(b) The development of the Geosynchronous Launch Vehicle Project (GSLV) and Cryogenics Project is the responsibility of the Vikram Sarabhai Space Centre at Trivandrum and Liquid Propulsion Systems Centre at Trivandrum respectively with participation from other Centres of Department of Space/Indian Space Research Organisation and Indian Industry.
