(b) No precise indication is yet available, although he has said that he would wish to visit India early.

(c) Prime Minister's invitation was handed over personally to Dr. Nelson Mandela at his house in Soweto near Johannesburg, South Africa on February, 14, 1990 by a Special Envoy. Dr. Mandela was very appreciative of India's role and profusely thanked the Prime Minister for the invitation. He indicated his intention to visit India as soon as possible.

Interference by Pakistan in internal affairs of India

260. SHRI GURUDAS DAS GUFFA: Will the Minister of EXTERNAL! AFFAIRS be please to state:

(a) whether Government have taken up the matter of interference by Pakistan into the internal affairs of India particularly with respect to the problems of Kashmir and Punjab with the leading countries of the world; and

(b) if so, the details and outcome thereof?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI I. K. GUJRAL): (a) and (b) Pakistan's interference in our internal affairs has been brought to" the attention of all concerned. Most countries approached have shown understanding for India's position.

Dilapidated condition of DTC main office at Connaught Place, New Delhi

261. SHRI PRITHIBI MAJHI: Will the Minister of SURFACE TRANS PORT be pleased to state:

(a) whether Government are aware of the shabby surroundings and lack of maintenance of D.T.C, main office operating in the heart of Connaught Circus, New Delhi despite owners of the premises offering their services in this behalf;

(b) whether there are no proper light points and the floors as well as utair-eases require heavy repairs in these D.T.C, premises located Scindia House, New Delhi; and

(c) whether an_v study has been undertaken by Government to ensure functioning of separate eat and tidy counters for tourists and local clients visiting this office throughout the day; if go, the details thereof?

THE MINISTER OF SURFACE WITH TRANSPORT ADDITIONAL THE, CHARGE OF MINISTRY OF COMMUNICATIONS (SHRI Κ. Ρ. UNNIKRISHNAN): (a) and (b) DTC has intimated that the sourrounding areas and the stair cases at their Scindia House Office are used by a large number of tenants and users. The DTC does not have exclusive control over these areas. These common areas have to be properly maintained by the owner and no action has been taken by the owner to property repair and maintain the common areas. Insofar as DTC Office is concerned, the premises have sufficient lighting points and are maintained in a satisfactory state.

(c) No study has been undertaken by Government regarding this. A neat and clean DTC tourist counter on the ground floor provides service to the tourists.
