Inquiry into lavish spending in a marriage in Bombay

310. SHRI MOSTAFA BIN **QUASEM:** SHRI ASHIS SEN: SHRI SUNIL BASURAY:

Will the Minister of Finance be pleased to state:

- (a) whether Government's attention has been drawn to the newsitem which appeared in the AAjkal of 21st January, 1990 regarding lavish spending in a marriage ceremony held at Bombay;
- (b) if so, whether CBDT officials of the area have been asked to file a report in the matter; and
- (c) what are the details in this regard?

THE MINISTER OF FINANCE (PROF. MADHU DANDAVATE): (a) Yes, Sir.

(b) and (c) Survey under Section 133A (5) of the Income-tax Act and related enquiries have been undertaken at Bombay to ascertain the quantum of expenditure incurred on the marriage ceremony of the daughter of Shri Bharat Shah and the son of Shri Kishore Mehta, both diamond merchants of Bombay. The enquiries include verification of expenses on wedding cards, decoration at Wankhede Stadium and Cooperage grounds catering, accommodation, private cars and taxies, tailors and drapers, sweetments, fireworks, light effects, sound system, video and photography and ascertaining the source of value of jewellery and other gifts given to the bride.
