"Bearer Bond" to mop up Black Money

- 360. SHRI S. S. AHLUWALIA: Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that 'Bearer Bond', introduced in 1980, to mop up black money for its positive utilisation in country's economic growth has fallen due for repayment; and
- (b) if so, what was the total sum collected through 'Bearer Bond' and how much has fallen due during 1990?
- THE MINISTER OF FINANCE (PROF. MADHU DANDA-VATE): (a) Special Bearer Bonds, 1991 were on sale in two phases, namely, from 2nd February, 1981 to 30th April 1981 and from 1st December 1981 to 9th January, 1982. The Bonds sold in the first phase upto 31st March 1981 will fall due for repa>ment from February, 1991.
- (b) The total realisation from the sale of the Bonds amounted to Rs. 964.26 crores. In 1\*90-91, Rs. 88 crores will fall due for repayment together with interest of Rs. 17.60 crores.
- . Export of Goods to Singapore, Bangkok and Hongkong
  - 361. SHRI S. S. AHLUWALIA: Will the Minister of COMMERCE be pleased to state:
  - (a) whether it is a fact that a number of firms have been exporting items only to Singapore, Bangkok and Hongkong;
  - (b) if so, how many have done such exports during the last five years, year-wise;
  - (c) whether some instances of such exporters' fraudulently extra©ting subsidy from Government have been detected during the above period; and

(d) if so, what are the detail\* thereof; yea\*-wise?

THE MINISTER OF COM-MERCE AND TOURISM (SHRI ARUN KUMAR NEHRU): (a) to (d) The existing policy does noi require maintenance of Country wise export figures as most of the exports are under O.G.L. However, cases of oxportars fraudulently taking subsidy are dealt with under the Indian Penal Cods and the Imp&rt & Export (Control) act, 1947 and Orders issued thereunder as and when detected by the Government.
