MINISTER OF URBAN THE DEVELOPMENT (SHRI MURASOLI MARAN): (a) No such decision has been taken in respect of the unauthorised construction which cannot be compounded under the relevant building regulations.

THE MINISTER OF LA **BOUR** AND WELFARE (SHRI RAM **VILAS** PASWAN): (a) to (c) World Labour Report 1989. brought .out by the International Labour Office states, inter alia, that in Asia, unemply-ment has been on the rise in, some countries since the beginning of

the 1980s. Young people constitute a sizeable proportion of the total unemployed in each Asian country including India. The problem is especially acute in the case of educated youth.
