

पहले से चुनी गई फीचर फिल्मों का पुनरीक्षण

1067. श्री अजीत जोगी : क्या सूचना और प्रसारण मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या दूरदर्शन पर प्रसारण के लिए पहले से चुनी गई फीचर फिल्मों का सरकार ने हाल ही में पुनरीक्षण किया है ;

(ख) यदि हाँ, तो यह पुनरीक्षण किस आधार पर किया गया है ; और

(ग) क्या हिन्दी फीचर फिल्म "मिली" का प्रसारण इन्हीं कारणों से रोक गया था ?

सूचना और प्रसारण मंत्री और संसदीय कार्य मंत्री (श्री पी. उषेन्द्र) : (क) और (ख) सरकार ने हाल में, अन्य बातों के साथ-साथ दूरदर्शन पर प्रसारण के लिए अनुमोदित फीचर फिल्मों की पुनरीक्षा करने, और उनकी गुणात्मक उपयुक्तता का फिर से मूल्यांकन करने के लिए एक पुनरीक्षा समिति गठित की है।

(ग) फिल्म "मिली" उक्त पुनरीक्षा समिति के गठन से काफी पहले अर्थात् 17 दिसम्बर, 1989 को दिखाई गई थी।

**Departmentalization of Postal seals Industrial Cooperative society**

1068. SHRI RAJNI RANJAN SAHU : Will the Minister of COMMUNICATIONS be pleased to state :

(a) whether it is a fact that the case of departmentalization of Postal Seals Industrial Cooperative Society is pending with Government since long ; and

(b) if so, what are the reasons therefor ?

THE MINISTER OF STEEL AND MINES WITH ADDITIONAL CHARGE OF THE MINISTRY OF LAW AND JUSTICE (SHRI DINESH GOSWAMI) : (a) No, Sir.

**Violation of Traffic Rules by Private Bus owners in Delhi**

1069. SHRI RAJNI RANJAN SAHU : Will the Minister of SURFACE TRANSPORT be pleased to state :

(a) whether it is a fact that the private bus-owners under DTC operation are not complying with the instructions of DTC regarding bus stoppages, time schedule, loading capacity and speed limit ; and

(b) if so, what is the number of cases brought to the notice of Government and the action taken against the owners/drivers of these buses ?

THE MINISTER OF SURFACE TRANSPORT WITH ADDITIONAL CHARGE OF THE MINISTRY OF COMMUNICATIONS (SHRI K. P. UNIKRISHNAN) : (a) and (b) For the purpose of regulating operation of Private buses under the DTC, regular checking is done by Checking Staff under the supervision of a Senior Officer of DTC. In addition, a Joint checking force comprising DTC and Police Officials remain mobile in the city and carry out regular checks on private buses. The violations as and when detected are dealt with, by imposition of penalties and issuance of warnings. During September 1989—February 1990, the penalty imposed has been Rs. 3.49 lakhs.

DTC has intimated that there has been no case where the private operator has not complied with the instructions.

**Setting of National Highway Authority**

1070. SHRI RAJNI RANJAN SAHU : Will the Minister of SURFACE TRANSPORT be pleased to state :

(a) whether Government propose to set up a National Highway
