Inclusion of Nepali language in Eighth Schedule of Constitution

974. SHRI RATNA BAHA-DUR RAI : Will the Minijter ofHOME AFFAIRS be pleased to state:

- (a) whether Government have received any petition/memoran dum regarding the Constitutional recognition of Nepali language from any quarter; and
- (b) if so, what is the stand of Government in respect of the demand of inclusion of Nepali Language in the Eighth Schedule of the Constitution?

THE MINISTER OF HOME AFFAIRS (SHRI MUFTI MOH-AMMED SAYED): (a) Yes, Sir.

(b) The consistent stand of the Government is that inclusion of more languages in the Eighth Schedule would create other repercussions and reactions. However, it is the endeavour of the Government to develop the literary and Cultural heritage of all languages irrespective of their inclusion in the Eighth Schedule. At presnt there is no change in the policy.
