for industrial workers on base 1982-100 declined to 175 in December, 1989¹ and to 174 in January, 1990.

(c) The decline in the All India Consumer Price Index for industrial workers during the months of December, 1989 and January, 1990 was mainly due to seasonal decline in the prices of Vegetables and Fruits and also of Cereals and Products, Pulses and Products, Condiments and Spices.

Employment to youths in rural areas

1274. SHRI SHIV PRATAP M1SH-RA: Will the Minister of AGRICUL-TURE be pleased to state;

(a) what is the number of youths provided with employment in rural areas in the country during the last three months; and

(b) what steps have been taken to increase employment opportunities m rural areas during the same period?

THE DEPUTY PRIME MINISTER AND THE MINISTER OF AGRICUL-TURE (SHRI DEVI LAL): (a) and (b) Jawahar Rozgar Yojana (JRY) and Integrated Rural Development Programme (IRDP) and Training of Rural Youth for Self-Employment (TRYSEM) are the major programmes being implemented to provide employment in the rural areas.

Under JRY, which is monitored in terms of employment generated in terms of mandays, about 2236 lakh mandays of employment is reported to have been generated from November, 1989 to January, 1990.

Under IRDP (the programme under which assistance is provided to families with annual household income of less than Rs. 4000/- for acquisition of assets sa that the beneficiaries can become selfemployed) which is monitored in terms of the number of families assisted, 933571 families were reportedly assisted in the period from November, 1989 to January, 1990.

Besides, under TRYSEM which is being implemented to improve the employability of the rural unemployed, 17051 tiainees were reportedly able to get self-employment and 3779 trainees were able to get wage employment in the period from November, 1989 to January, 1990.

Department of Rural Development monitor these programmes closely so that optimum benefits accrue to the rural poor and unemployed from these programmes.
