

THE MINISTER OF LABOUR AND WELFARE (SHRI RAM VILAS PASWAN); (a) and (b) The Contract Labour (Regulation & Abolition) Act, 1970 does not envisage complete abolition of employment of contract labour. Since the enactment of Law and in pursuance of the recommendations of Central Advisory Contract Labour Board, the Central Government have prohibited employment of contract labour in various jobs/processes in Coal, Iron Ore, Mica, Magnesite, Chrome, Gypsum and Fire-Clay Mines. In addition, the employment of contract labour has also been prohibited in some jobs/processes in coal washeries, railways and in sweeping, cleaning and watching of buildings owned or occupied by establishments in respect of which the 'appropriate Government' under the above Act was the Central Government. State Governments have also been enforcing provisions of the Act in respect of establishments for which they are 'appropriate Government',
