THE MINISTER OF LABOUR AND WELFARE (SHRI RAM VILAS The Contract WAN): (a) and (b) Labour (Regulation & Abolition) Act, 1970 does not envisage complete tion of employment of contract labour, Since the enactment of Law and in pursuance of the recommendations of Central Advisory Contract Labour Board. the Central Government have prohibited employment of contract labour in various jobs/processes in Coal, Iron Ore, Mica, Magnesite, Chrome, Gypsum and Clay Mines. In addition, the employment of contract labour has also been prohibited in some jobs/processes in coal washeries railways and in sweeping, and watching of buildings owned or occupied by establishments in respect of which the 'appropriate Government' under above Act was the Central Government. State Governments have also been forcing provisions of the Act in respect of establishments for which they are 'apropriate Government'.
