## Structural pattern of excise duty levied on match industries

- (b) whether Government are aware that due to the anomaly in the levy of excise duty the hand-made (medium-scale) match industries suffer to the extent of extinction-
- (c) whether Government have received representations from the owners of medium-sized match industries of Kamraj district of Tamil Nadu in this behalf;
- (d) if so, what steps Government propose to take to help them; and
- (e) whether Government have any proposal to change the structural pattern of levy of excise duty among different sectors of match industry to save such **units** from extinction?

THE MINISTER OF INDUSTRY SHRI AJIT SINGH): (a) The present excise duty structure on match industry is as given below:—

(b) to (e) The above duty rates have been fixed taking into account the interests of various sectors of match industry including handmade sector. (d) and (e) Efforts to find alternative fuels for transportation project using methanol and diesel in dual fuel mode. The diesel replacement varied between 12 to 18 per cent. Another project has been sanctioned to find out technical viability under actual conditions, Demonstration programmes of battery operated
