(e) whether the customers already registered with" the said agency can have their gas connection transferred to airy other agency under Indian Oil or Hindustan Petroleum etc. and what' is the procedure therefor?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI M. S. GURUPADASW.&MY): (a) Ho, Sir. One complpaint during the last six months received in this regard on enquiry was not substantiated.

#### Shortage of quality paper

- 1452. CHOWDHRY HARI SINGH: Will the Minister of ENERGY be pleased" to state:
- (a) whether Government are aware of the present shortage of quality paper in the country resulting in sudder rise in its prices; and
- (b) if so, what are the reasons therefor and what steps Government propose to take to meet this shortage and check the rising prices?

THE MINISTER OF INDUSTRY (SHRI AJIT SINGH): (a) and (b) In general, there has been no report regarding shortage of writing and printing papers in the country. Various units in the Paper Industry produce different varieties of paper, as per the domesic demand. Industry sources have also indicated that the prices of writing and printing paper have been ruling stable for the last several months.

# Requirement for Petnoleum and **Petroleum Products**

1453. CHOWDHRY HARI SINGH: SHRI GUFRAN AZAM:

Will the Minister of PETROLEUM AND CHEMICALS be pleased to state;

- (a) whether it is a fact that the requirements of petroleum and petroleum products in he country are steleply sising and domestic production is not going up in adequate measure; and
- (b) if so, what steps are proposed to be taken to meet the oil crisis, and reduce import of these products?

THE MINISTER OF PETROLEUM (SHRI AND CHEMICALS GURUPADASWAMY): (a) Yes, Sir.

(b) The gap 'between the demand and the indigenous production is presently being met through imports of crude oil and petroleum products. In order to increase the production of petroleum products, the refining capacity in the country is proposed to be increased by setting up new refineries and by taking up expansion/debottlenecking projects in some of the existing refineries. Steps are also being taken to increase crude oil production which, inter alia include intensification of exploration which may eventually lead to enhanced production, intensification of work-over operations and use of enhanced oil recovery techniques. The prices of selected petroleum products such as motor spirit and HSD have been recently revised upwards to contain the rate of growth in demand for petroleum products.

#### Import of crude oil during the year 1990

- 1454. CHOWDHRY HARI SINGH Will the Minister of PETROLEUM AND CHEMICALS be pleased to state.
- (a) what are the names of the countries from which Government are importing crude oil during the year 1990;
- (b) what is the currency in which payment would be made;
- (c) by when the above imported crude is likely to reach the country; and
- (d) what steps Government propose to take to lessen the import of crude?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI M. S. GURUPADASWAMY): (a) In the year 1989-90 we have term contracts for the import of crude oil with USSR, Saudi Arabia, Iran, Iraq, UAE and Kuwait. Term contracts for 1990-91 have not been finalised. With USSR, the term contract is on calendar year basis for 1990. In addition, spot purchases are made from producers|traders of crude oil all over the world except certain prohibited countries like South Africa and Israel.

(b) All payments are made in U.S. dollars except for imports from USSR where payments are made in Rupees.

- (c) The imports are phased over the entire year to meet the demand and operational requirements of the refineries.
- (d) Steps being taken to reduce imports of crude oil include (i) increase in crude all production by intensification of exploration activities, intensification of work over operations and use of enhanced over recovery techniques, (ii) increase in refining capacity, and (iii) effecting economy in the use of petroleum products by efforts towards increasing fuel efficiency in user sectors.

Recently the prices of some petroleum products such as Motor spirit and HSD were raised to contain the rate of growth of demand for these products.

THE MINISTER OF ENERGY WITH ADDITIONAL CHARGE OF THE MINISTRY OF CIVIL AVIATION (SHRI ARIF MOHD. KHAN): (a) and (b) Following the crash of A-320 aircraft at Bangalore, an accredited reprentative of French Investigation Buieau alongwith his technical advisers of Airbus Industries were in India to provide technical information on the A-320 aircraft required for investigation.
