

### Attacks on Journalists and Cameramen at Meham

1894. SHRI ANAND SHARMA : Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether Government are aware of the reported attacks on journalists and cameramen at Meham during the polling on 27th and 28th of February ;

(b) the number of journalists injured in the said incidents ; and

(c) the steps, if any, proposed to be taken to ensure security of journalists covering elections, demonstrations, etc. in future ?

THE MINISTER OF HOME AFFAIRS (SHRI MUFTI MOHAMMED SAYEED) : (a) and (b). Yes, Sir. Full facts are being obtained from the State Government.

(c) Under the VII Schedule to the Constitution 'Public Order' and 'Police' are State Subjects. The primary responsibility for maintenance of law and order during elections thus directly devolves on the State Government.

(ख) क्या सरकार इस कार्य को निकट भविष्य में पूरा करने या इसे लम्बित रखने का विचार रखती है ?

(ख) इन्सैट-1डी के माध्यम से उपग्रह क्षमता के सुलभ होते ही इस कार्य को पूरा करने की योजना है।
