holding an industrial licence under the Industries (Development and Regulation Act, 1951 (65 of 1951), for slitting and confectioning of photo-sensitised materials from jumbo rolls. It is not possible to make any estimate whether and to what extent there is non-payment of excise duty and sales tax by these units. Statistical information regarding production and profits made by such units is not being maintained.

## Import of Colour Photographic Jumbo Rolls

Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that officials of the Directorate of Revenue and Intelligence have apprehended M/s. NPL importing high width colour photographic jambo rolls as shorter width rolls and cheating Government of Cuatoms duty to the tune of Rs. 4 to 5 crores as reported in the Indian Express, Bombay of the 1st February, 1990;
- (b) whether the Directorate of Revenue and Intelligence is probing into their past imports as reported in the press; and
- (c) what steps Government propose to take to check such clandestine imports?

THE MINISTER OF FINANCE (PROF. MADHU DANDAVATE): (a) and (b) In connection with the complaint regarding imports of photographic colour ruper in jumbo rolls by misdeclaration of the width by Mis. Northern Plastics ! td. joint searches were conducted by the Directorate of Revenue Intelligence Intelligence and the Central Economic Bureau on 24-1-90 at their office and factory premises. Incriminating documents and goods were seized during the searches Preliminary investigations reveal that the firm was misdeclaring the actual width of films. The past imports made by the firm are also being scrutinised. Investigations are in progress.

(c) Appropriate steps will be taken on completion of investigations.

## Import of Jumbo Rolls

- (a) whether it is a fact that in 1984, the additional Economic Adviser to the Ministry of Industry advised CCI&E to permit import of jumbo rolls of photo sensitised goods only by HPF;
- (b) if so, what are the reasons for Economic Adviser recommending import of jumbo rolls only by HPF;
- (c) whether the jumbo rolls are subject to inspection at the ports;
- (d) what is the annual tonnage of jumbo rolls being imported under OGL; and
- (e) whether it is also a fact that the jumbo rolls are being imported without being inspected at the customs; if so, what are the reasons therefor?

THE MINISTER OF COMMERCE AND TOURISM (SHRI ARUN KUMAR NEHRU); (a) Yes, Sir.

- (b) The recommendation regarding import of jumbo rolls only by M|s. Hindustan Photo Films Manufacturing Co. Ltd., was made having regard to large investments made by Government and in the light of the proposed expansion programme for integrated maunfacture of all photo-sensitised goods.
- (c) and (e) Jumbo rolls of photo sensitive goods on import are subjected to inspection at all ports by the customs authorities before clearance. Inspection is done to verify the discription, length, width etc. With reference to the documents produced for clearance. The packages are not opened in entirety for
