Direction to banks and tax officials to unearth black money

THE MINISTER OF FINANCE (PROF. MADHU DANDAVATE): (a) to (c) Combating tax evasion is a continuous process and the Government take necessary steps from time to time to curb the generation, growth and use of black money. These measures include, inter-alia;

- (i) Systematic survey operations;
- (ii) Search and seizure operations in appropriate cases;
- (iii) Verification of information in a planned manner; and
- (iv) Indepth investigation in manageable number of selected cases.

Some instances of suspected benami accounts have come to the notice of the Income Tax Department. Central Bureau of Investigation is also investigating into some of these accounts. The Reserve Bank of India has also issued detailed instructions to the banks to ensure that benami of fictitious accounts are not opened by them. Banks have also been advised that they must extend necessary help/ coordination to the tax officials whenever required.
