Since the Scheme has been basically a part of the employment generation programmes, wage component of the Programme has to be more than the material component. This requirement of the programme cannot be satisfied by digging surface borewells. The programme is accordingly confined to open wells only.

As per the guidelines under the Scheme, it is to be talcen up only in those areas where open wells are the cost effective mode in comparison to irrigation through tube-wells or surface borewells.

(a) whethei- it is a fact that the Delhi Administration have started demolishing the constructions that were carried out in Delhi colonies;

(b) whether it is a'lso a fact that the l people living in colonies have objected to the same since they are! living in the said colonies since long; and

(c) what steps Government is taking for regularising unauthorised construction in various colonies in Delhi?

THE MINISTER OF URBAN DEVE-LOPMENT (SHRI MURASOLI MARAN): (a) to (c) The Local bodies having jurisdiction have to take action against unauthorised construction and encroachments. The performance of this duty by the Local Bodiels is generally opposed by the people involved.

There is no proposal under consideration of the Government to regularise the unauthorised constructions in the various colonies of Delhi.

(d) if so, what efforts have been made by Government to make available the Nigee seeds oil to the<sup>1</sup> common people and Ayurvedic medicines manufacturing firms at reasonable rates; and

(e) whether Goveinment would put a ban on the export of Niger seed due to its domestic demand?

THE MINISTER OF FOOD AND CIVIL SUPPLIES (SHRI NATHU RAM MIRDHA): (a) As a short term mear sure Government is importing edible oils, not oilseeds to> partly meet the demand in the country.

(b) Niger seeds mostly grow in tribalinhabitated areas. Some quantity of export of nigerseeds has been allowed. This wi'il improve the marketability of the nigerseeds and in the<sup>1</sup> process will ensure some economic benefit3 to<sup>1</sup> the tribal people.

(c) to (e) Government is not aware that niger,; eed oil is being used in Ayurvedic Medicines. Present availability and price's of nigerseed are reasonable and do not warrant a ban on the export of Niger Iseed.
