THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SMT MANEKA GANDHI): The Government has taken a number of steps as given below to improve the environment and to protect forests:

- Schemes for soil conservation, waste land development, protection of watershed areas, desert development, hill development and reclamation of saline and alkaline areas.
- Schemes for conservation of both ground and surface water, flood control, prevention and control of water pollution through implementation of the Water (Prevention and Control of Pollution)
   Act, 1974 and the Environment (Protection) Act, 1986 and cleaning up the river Ganga under the Ganga Action Plan.
- Prevention and control of air pollution through the implementation of the Air (Prevention and Control of Pollution) Act, 1981 and the Environment (Protection) Act, 1986.
- Survey and identification of critical areas in flora, fauna and forests through the Botanical, Zoological and Forests Surveys of India.
- Protection of forests through the implementation of the Indian Forest Act, 1927 and the Forest (Conservation) Act, 1980, development of non-conventional energy sources and schemes for substitution of wood.
  - 6. Afforestation Programmes.
  - 7. Preservation of critical ecosystems and protection of wild life through 69 National Parks and 397 Sanctuaries and through implementation of the Wildlife (Protection) Act, 1972.

- Action programmes for marine eco-systems, wetlands and mangroves.
- Formulation of policy and strengthening of legislation for environment and forestry
- Promotion of research, education, and training in environmental and forestry subjects.
- Creation of environmental awareness.

99. SHRI KAILASH PATI MISH-RA: Will the PRIME MINISTER be pleased to refer to answer to Unstarred Question 2876 given in the Raiya Sabha on the 9th August, 1939 and state:

(a) whether in February, 1989 the Rashtriya Veda Vidya Pratishthan had recommended sanctioning of 3 different types of projects on Vedic Mathematics to competent mathematicians and computer scientists;

- (b) if so, what was the nature and type of the suggested three projects;
- (c) the name, status and address of the mathematicians and computer scientists to whom each project has been sanctioned; and
- (d) the guidelines and outline of the action scheme regarding each of the projects?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY (PROF. M. G. K. MENON): (a) and (b) Yes, Sir. The three projects are:

- (i) Propagating the ideas brought out in the book 'Vedic Mathematics' written by Jagadguru Shankara-charya;
- (ii) Exploring the possibilities of application of these ideas in appropriate computer software programmes; and
- (iii) Expounding and developing mathematical foundations behind the various sutras.
- (c) and (d) The Project Committee of the Rashtriya Veda Vidya Pratishthan has approved grant of a fellowship for research in Vedic Mathematics at the school level in the light of the book of Jagadguru Shankaracharya. The fellowship has been offered to Smt. Ranjana Chari, a teacher in the Kendriya Vidyalaya Sangathan to promote and carry out research into Vedic Mathematics for the purpose of establishing its applicability to modern mathematics.
