- 83. SHRI P. N. SUKUL: Will the PRIME MINISTER be pleased to state:
- (a) whether Government propose to re-examine the Approach Paper prepared for Eighth Five Year Plan and the priorities for development in that Plan; and
- (b) whether the Eighth Five Year Plan is to start from the next financial year or its commencement would be delayed in view of the exercise referred to in part (a) above?

THE PRIME MINISTER (SHRIVISHWANATH PRATAP SINGH):

(a) The Approach Paper for Eighth Five Year Plan has not been finalised. It will reflect the economic philosophy and objectives of the present Government.

(b) The Eighth Five Year Plan is scheduled to begin on April 1, 1990.

Supersession of NCCF Board
