## Resignation and Transfer of Assistant Directors in B.I.S.

131. SHRI MOHD. KHALEELUR RAHMAN: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to refer to answer to Unstarred Question 2135 given in the Rajya Sabha on the 4th August, 1989 and state:

(a) what is the period during which, each of the three Assistant Directors, who have resigned, were with the Bureau of Indian Standards and the amount recovered from each of them for not serving the B.I.S. for a minmum period of three years,

as required under the undertaking given by them:

- (b) whether the two Assistant Directors, whose requests for transfer to B.I.S. Headquarters, New Delhi, had been pending, have since been transferred to New Delhi; and
- (c) if not, the dates on which each of them had applied for transfer and the dates on which each of them had been communicated the decision of the Bureau of Indian Standards?

THE MINISTER OF FOOD AND CIVIL SUPPLIES (SHRI NATHU RAM MIRDHA): (a) The required information is as follows:

- Amount recovered from them for not serving the BIS for 3 years
- Rs. 11,869.00 recovered. In addition to this, he was not paid any salary for the period from 1-7-1989 to 3-7-1989.
- 2. Rs. 4,517.00 recovered. In addition to this, he was not paid any salary for the period from 1.5.1989 to 26-5-1989.
- He was not paid any salary for the period from 31-3-1989 to 19-4-1989 and hence no recovery was made from him.
- (b) and (c) Out of two Assistant Director, Assistant Directors, one initially posted at Bhopal had applied for transfer to B.I.S. Headquarters, New Delhi on 25th May, 1989. After consideration of his case, he transferred to New Delhi against vacancy which had become available as a result of resignation of Shri Puneet Rathi. The second Assistant Director, posted at B.I.S. Regional applied for Office, Calcutta, had tranfer to B.I.S. Headquarters, New 1989 July, 3rd Delhi, on completing his dissertation assignment for M. Phil degree at the University of Delhi Since this work a can be completed within months and due to non-availability of a suitable vacancy in the discipline to which he beolngs, it has not been found feasible for BIS Management to transfer him New Delhi on permanent/regular basis. He has been asked by BIS Management vide memo dated 20th December, 1989 to indicate the period for which he would like to be transferred temporarily to New Delhi in order to enable him to complete the said assignment. Further action will be taken by Management on receipt of his reply.

## Inter-regional transfer<sub>S</sub> of teachers of KVS

132 SHRI N.E. BALARAM. Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the last date for effecting inter-regional transfers of teachers of Kendriya Vidvalaya Sangathan, as provided in the Transfer Guidelines, is 31st October;
- (b) if so, the reasons for not adhering to the prescribed time schedule; and
- (c) what is the fate of promotees to the post of Post Graduate Teachers who have not been offered promotional postings before transfers?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY (PROF. M. G. K. MENON): (a) Yes, Sir

- (b) The placement of teachers on account of revision of annual staff strength of Kendriya Vidyalayas for 1989-90 took sometime and consequently information about the availability of vacancies in various teaching posts was delayed.
- (c) The National Society of Physical Education Teachers in Kendriya Vidyalaya Sangathan, Madras. has High filed a writ petition in the Court of Madras, praying that Physical Education Teachers in Vidyalayas should also be considered the posts of Post for promotion to Graduate Teachers as in the case of Trained Graduate Teachers departmental promotion quota as soon as they acquire Post-Graduate qualifications in a school subject. At present, Physical Education Teachers are not treated as feeder category for the posts of Post Graduate Teachers. Legal Adviser, Kendriya Vidyalaya Sangathan, has advised that it would be desirable to get the direction of High Court of Madras before effecting promotions of Trained Gra-Graduate  $Teacher_{S}$  as PostTeachers. Meanwhile, with a view to avoid delay in filling up vacancies of Post Graduate Teachers in Kendriya Vidyalayas, it was decided, on the orders of then Chairman, Kendriya Vidyalaya Sangathan, to effect transfers of Post Graduate Teachers before effecting promotions of Trained
