USSR and other countries producing heavy water is not available. By improving performance of our heavy water plants, the cost of production is being brought down progressively.

## Plea against Construction of Tehri Dam Project

- \*39. SHRI SURENDRA SINGH THAKUR: Will the PRIME MINISTER be pleased to state:
- (a) whether Government are aware of the plea made by some environmentalists against the construction of Tehri Dam Project;
- (b) if so, what are the details thereof;
- (c) whether Government would consider their plea against construction of Tehri Dam; and
- (d) if so, by when and in what manner?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRIMATI MANEKA GANDHI): (a) Yes, Sir.

- (b) The plea against the Tehri Dam Project is based on apprehensions regarding the safety of the tham, displacement of large population and other adverse environmental impacts and economic viability considerations.
- (c) and (d) The Tehri Dam Project was approved by the Planning Commission in 1972 when no environmental clearance was required. The scope of the project was subsequently enlarged. On the basis of a review ordered in 1980, a Working Group has submitted its report on aspects of the the environmental project. The project authorities have also submitted modified environmental action plans. Amongst others, the findings of the Working Group and the views of the environmentalists are kept in view for environmental scrutiny of the action plans.

## Acquisition of Fire-Finding Radars by Pakistan

- \*40. SHRI PAWAN KUMAR BAN-SAL: Will the PRIME MINISTER be pleased to state:
- (a) whether it is a fact that Pakistan have acquired the latest sophisticated fire-finding radars; and
- (b) if so, what steps have been/are being taken to counter the same?
  THE PRIME MINISTER (SHRI VISHWANATH PRATAP SINGH):
  (a) Yes, Sir.
- (b) On the basis of regular appraisal of threats to the nation's security, appropriate measures are taken to ensure adequate defence preparedness. Divulging further details will not be in the interest of national security.
