Rise in Cost of Training of IAF Pilots

THE PRIME MINISTER (SHRI VISHWANATH PRATAP SINGH): (a) to (c) Cost of training of IAF pilots is worked out on a yearly basis. As the training pattern, flying syllabus and all other training infrastructure have remained uncharged in the last few months, no steep increase in training charges is anticipated on these accounts. Details of the amount spent per pilot during 1988 on training, are given below:-

Stage I—Rs. 20.60 laghs.

Stage II—Rs. 34.26 laks.

Stage III.

- (a) Fighter Stream—Rs. 73.82 lakhs
- (b) Transport Stream—Rs. **40.83** lakhs
- <c) Helicopter Stream—Rs. 10.00 lakhs

Training in all the above three stages is imparted within the country. In a few cases, pilots have been sent abroad, like other categories of personnel, for specialised training, chiefly relating to specific equipment.
