Or-ders relating to the transfer of 407. 82 acres of Government land in laggaraju-peta and Narava Villages of Gajuwaka Mandal of Visakhapatnam District to the Central Government has been issued by the State. Government on 30-6-1989. The Development Commissioner for the Zone has also been appointed.
