Services Programme was started in July, 1986 with an allocation of Rs. 27.60 crores which was to be shared between the Central Government, State Governments and UNICEF on a 20:40:40 basis. The Central Government's commitment was limited to Rs. 5.00 crores in the Seventh Plan against which Rs. 2.12 crores has been released so far. The revised allocation for 1989-90 is Rs. 95 lakhs which is expected to be utilised.

(c) No physical targets at the all India level are fixed. The programme is based on eliciting the felt needs of the people as assessed and determined at the neighbourhood level. Schemes are then implemented through active community participation. The activities undertaken are given in Annexure [Vide unstarred Question, 482(b), supra].

## Food and Agriculture Organisation Assistance for promotion of Animal Husbandry in Rajasthan

(a) whether F.A.O. is giving aid to the country for promoting Animal Husbandry in the country; and

(b) if so, the aid received from F.A.O. so far and the amount spent in Rajasthan from the aid?

THE DEPUTY PRIME MINISTER AND THE MINISTER OF AGRICUL-TURE (SHRI DEVI LAL): (a) and (b) Yes, Sir. F.A.O. have recently concluded agreement with Government of India for providing assistance to three ICAR Institutes as under:-

- US \$ 8000 to IVRI, Izatnagar for promoting research on Embryo Transfer;
- (ii) US \$ 8000 to NBAGR, Karnal genetic characterisation of indigenous livestock breeds;
- (iii) US \$ 5000 to NDRI, Karnal for strengthening research on Bietechnology.

As these are project linked assistance, on amount is earmarked for Rajasthan.
