tion the techno-economic feasibility of the Mass Rapid Transit System (MRTS). With a view to get the techno-economic feasibility examined and also to suggest corridors which would cater to the traffic demands of Delhi by taking into consideration the present available traffic infrastructure, the Delhi Administration have entrusted the Rail India Technical & Economic Services Ltd. (RITES) with the task of preparing a detailed Feasibility Report. The Report will also take into account recommendations of the previous committees and suggest appropriate alignments for the proposed system. The report is due by May, 1990.

Allotment of quarters lying vacant in Sarojini Nagar

- 564. DR. RATNAKAR PANDEY: Will the Minister of URBAN DE VELOPMENT be pleased to state:
- (a) whether it is a fact that many quarters adjoining to Pillanji village in Sarojini Nagar Colony are lying vacant;
- (b) if so, the number thereof and since when;
- (c) whether it is also a fact that most of the quarters are being misused by unauthorisedly occupied by some contractors and villagers; and
- (d) if so, what action Government propose to take to re-allot these quarters to the Central Government employees?

THE MINISTER OF URBAN DE-VELOPMENT (SHRI MURASOLI MA-RAN): (a) to (d) The information is being collected and will be placed on the Table of the Sabha.

Laying of grass and fencing in Sarojini Nagar

- 565. DR. RATNAKAR PANDEY: Will the Minister of URBAN DE VELOPMENT be pleased to state:
- (a) whether it is a fact that Government have received a number of complaints from X and Y Blocks Association of Sarojini Nagar regarding laying of grass and fencing on the grounds in the

- blocks, by the Horticulture Department of the CPWD;
- (b) whether it is also a fact that the Department do not attend to the request made by the office bearers of the above association; and
- (c) if so, what steps Government propose to take in this regard?
- THE MINISTER OF URBAN DE-VELOPMENT (SHRI MURASOLI MA-RAN): (a) Yes.
- (b) and (c) Requests/complaints are attended to as and when received. In some blocks, lawns have been repaired and fencing done. All efforts are being made to maintain the lawns in a satisfactory state.

Unscrupulous agents indulging in illegal manpower export

- 566. SHRI HARVENDRA SINGH HANSPAL: Will the Minister of LABOUR be pleased to state:
- (a) whether the unscrupulous agents indulging in illegal manpower export are trying to hoodwink the authorities to escape raids at their premises;
- (b) whether the Protector General of Emigration in Trivandrum and Madras has recently nabbed such illegal agents; and
- (c) if so, the details of the unscrupulous agents nabbed and the action taken by Government against them so far?

THE MINISTER OF LABOUR AND WELFARE (SHRI RAM VILAS PASWAN): (a) No person can carry on the business of overseas recruitment after the commencement of the Emigration Act, 1983 unless he has obtained a certificate to carry on this business from the Registering Authority. Any contravention of this provision has been made a cognizable offence under the Act. As and when any information regarding illegal manpower export is received by the Ministry the same is passed on the concerned police authorities for necessary legal action.

(b) and (c) Yes, Sir, on receiving the

information about illegal recruitment the protectors of Emigrants at Trivandrum and Madras carried out search at the places concerned with the help of local police. Incriminating documents were seized in the course of the search. One person was arrested and he has been remanded to judicial custody for 12 days.
